DAY 1	1926 Subpart AA Confined Space course Training (CSE-C) - United Rentals offers Confined Space Entry Training designed for all workers who may enter supervise entry or be adversely affected from confined spaces. Our training courses are designed to help workers identify any potential hazards associated with a confined space. The course addresses 29 CFR 1926 AA Construction standards and requirements including the duties and responsibilities for an Authorized Entrant, Attendant, Entry Supervisor and Rescue Personnel.
DAY 2	Trench & Excavation: Competent Persons Training - United Rentals offers Competent Person Training seminars designed for all employees involved in trenching work, including job foremen, job superintendents, engineers and any personnel involved in underground projects. According to OSHA 29 CFR 1926 Subpart P, every excavation must have a designated Competent Person to manage the safety aspects of the site. To properly carry out Competent Person responsibilities, this individual must have training in, and be knowledgeable of, soil analysis, the use of protective systems and the requirements of the standard.
